



## 2025 Spring Meeting Notes

### 1. Regional Payments & State Meet Spots

- **Action Item:** Regional payments for the state meet are due to Oksana.
- **Information:** There are currently 22 spots available for Level 5 at the state meet.
- **Information:** Additional spots may become available after the state meets on March 23rd and will be distributed to other regions.

### 2. Financial Report

- **Information:** A previously identified error has been corrected. The financial status is reported as good.

### 3. State Committee Applications

- **Information:** One state committee application has been received from Doug (board member).
- **Information:** TCT Jaylon intends to apply for the State Chair position.
- **Decision:** Oksana was re-elected for a 2-year term.

### 4. New Business

- **Club Program**
  - **Discussion:** Review of club program rules and potential implementation at local clubs.
  - **Information:** The club program is similar in structure to the Xcel levels.
  - **Explanation:** Kostya explained the benefits of the club program, including its suitability for D2 and part-time athletes.
  - **Reference:** Rules for the club program can be found in the manual.

- **Outcome:** There was significant interest and discussion regarding the program and how to initiate it.
- **State Patches & Academic Letter**
  - **Decision:** The continuation of state patches and the academic letter was met with approval.
- **2024-25 NGJA Summary (Ron Hill)**
  - **Plea:** A request was made for new judges.
  - **Update:** One new judge (David from Gleasons) has been added.
  - **Financial Proposal:** A proposal to add a \$0.05 head tax for optional and \$0.10 for compulsory judging to cover training costs.
  - **Financial Update:** Funds were used to pay for the training of 3 judges.
  - **Proposed Fee:** A \$20 fee is proposed when judges are required to judge both compulsory and optional routines at the same meet.
  - **Future Event:** The next Judges Clinic will be held in the Fall.
- **2025 Team MN Clinic**
  - **Date:** June 8th
  - **Location:** MHG
  - **Discussion Points:**
    - New pay program for coaches.
    - Request for coaches to sign up for specific event responsibilities.
    - Identification of topics to help grow the program.
    - Skills to focus on.
    - Webinars for additional coach education.
    - Structuring the program for future growth.
    - Level progressions.
